4. INTRODUCTIONS

Chair Ruehlig welcomed newly appointed Library Commissioners Porfirio Loeza, representing the City of Pinole; Anne Cleary, representing Contra Costa Council; Christina Mengel, alternate representing the Friends Council. Also present at the meeting: Pleasant Hill resident John Cerrito; library patron Bob Leffman; former Library Commissioner Carroll Beard and his wife Pat; Library Collections and Technical Services Manager, Julie Italiano; Administrative Services Officer, Susan Caldwell; Deputy County Librarian: Public Services, Rose-Marie Westberg; Deputy County Librarian: Support Services, Cathy Sanford; Executive Secretary, Corinne Kelly; County Librarian, Anne Cain.

5. ITEMS FROM THE PUBLIC

There were no items from the public.

6. ACCEPTANCE OF MINUTES - *Agenda Attachment 1*

The minutes from the January 27, 2005 Library Commission meeting were approved as submitted.

7. APPROVAL OF AGENDA

The agenda for the March 24, 2005 Library Commission meeting was approved.

8. ITEMS OF INTEREST TO THE COMMISSION AND ANNOUNCEMENTS

Former Library Commissioner Carroll Beard was presented a plaque and an acrylic library logo for his service on the Contra Costa County Library Commission representing the City of Pinole from April 5, 1993 through December 31, 2004. County Librarian Cain mentioned that Beard has been an active member of the Pinole Library Friends and will be missed. Beard plans to spend much of his time at his new residence in Alabama. *(attachment #1 to the minutes)*

A plaque and an acrylic library logo was also prepared for former Commissioner Hope Scott, appointed by District 1, who served on the Library Commission from April 1, 1993 through January 21, 2005. Scott was not able to attend this Commission meeting.

Commissioner Hoisington mentioned the popularity of Lafayette Library's newsletter, prepared by the Branch Librarian. She also shared an invitation for the City of Lafayette's April 17, 2005 kick-off event for the new Lafayette Library.

Commissioner Barnhart said that she was accepted at UC Santa Cruz and this is her final Library Commission meeting. Cain thanked Barnhart for participating on the Library Commission and said that Barnhart is extremely active in the Countywide Youth Commission, which has developed the possible theme for the library's next Teen Reading Program; *See the Movie, Read the Book*.

Commissioner McClellan presented an advertisement slide for the Moraga Friends' bookroom that is shown at the Rheem All-Stadium 4 Theatres in Moraga. The advertisement states that the Friends of the Moraga Library provide thousands of dollars each year for the Moraga Library. The Rheem Theatre charged the Friends a non-profit reduced rate for the publicity and the slide costs \$185 to create. Commissioner Myric arranged a mailing to all residents in Moraga in conjunction with the slide publicity. Results from the publicity include new memberships and donations. Moraga Friends applied for a Starbucks grant and contacted Wells Fargo and Orchard Supply Hardware for grant opportunities.

Chair Ruehlig mentioned library volunteers and suggested that the accumulative hours that volunteers spend on the library's behalf could be used as another form of library publicity. Ruehlig mentioned that he attended January 28, and February 4, 2005 CLA Legislative Day in the District and shared the information packet. Ruehlig mentioned the 28th annual Sutter Delta Run in Antioch that raised \$6,000 for libraries. Ruehlig shared information about the East County Women's Conference on April 1, 2005 for those interested in attending. Ruehlig attended the March 5, 2005 CALTAC workshop at the Dublin Library and shared pictures from the event. The featured speaker was State Librarian Susan Hildreth who shared insight on how libraries can make a difference in the community. County Librarian Cain talked about library collaborations. He shared fundraising ideas from the workshop that included passport processing, selling books by the pound on Friday nights, and he mentioned a Santa Cruz Library has corporations sponsor a promotional piece saying "We All Love Libraries, But Libraries Can't Live on Love Alone" *(attachment #2 to the minutes)*. Commissioner Hoisington added that she also attended this workshop and learned that Friends have been successful recruiting members with reading booths at local farmers markets.

9. CORRESPONDENCE

There were no Library Commission correspondences.

10. REPORT FROM COUNTY LIBRARIAN

County Librarian, Anne Cain, reported that the California Library Association's (CLA) Legislative Day in

Sacramento is on Wednesday, April 20, 2005. Appointments with Contra Costa County State Legislators are being arranged and a sign up sheet was passed around for Commissioners that wish to participate and/or carpool to the event. (*attachment #3 to the minutes*) There are no major library legislative funding items at this time, so these meeting will be mostly to thank the legislators for supporting libraries. Commissioner Austin said that he attended CLA's Legislative Day last year and found the event interesting and that Commissioners should consider participating.

On March 19, 2005, Danville's Senior Branch Librarian, Stephanie vanOgtrop, passed away after a courageous fight with breast cancer. She worked for Contra Costa County Library for 36 years, 25 years as the Branch Librarian in Danville. Cain shared a Contra Costa Times article about vanOgtrop (*attachment #4 to the minutes*).

The library's annual staff training day was on March 14, 2005. The library was closed so that all staff can participate together. Cain mentioned the excellent speakers and training that was made available to staff including author Lynne Lancaster, who wrote *When Generations Collide*, which is about four different generations working together and how the different generations influence the workforce.

Administration Services Officer, Susan Caldwell, announced that July 24, 2005 will be the second annual 5K Fun Run/Walk and said that the library is seeking volunteers and sponsorship. She distributed a sponsorship opportunity flyer (*attachment #5 to the minutes*). Library staff is available to give a presentation about the event to groups that would like more information.

The annual volunteer recognition event at the Board of Supervisors meeting will be Tuesday, April 12, 2005. The recognition will be handled differently this year, with a reception in the Board's new conference room at 2pm, following the regularly scheduled Board of Supervisor's meeting.

11. BAY AREA LIBRARY & INFORMATION SYSTEM (BALIS) LAY ADVISORY BOARD REPORT

There was not a BALIS Advisory Board report.

12. OLD BUSINESS

There was no old business discussed.

13. NEW BUSINESS

LIBRARY BUDGET - Agenda Attachment 3

Administrative Services Officer, S. Caldwell, reported on the library's balanced budget for fiscal year 2005-2006 that was recently submitted to the County Administrator. The County Administrator asked that all departments submit their budgets earlier this year to be able to consider budget changes and reductions.

Caldwell highlighted library expenses including the utilities and general maintenance costs, which make up 7.7% of budget

Caldwell highlighted changes in this year's budget including:

Revenue:

- \$1 million (7%) increase in property tax, determined with the County's Assessor and Auditor
- Unique Management System (UMS), material collection agency

-
- The State's Public Library Fund (PLF), about \$350,000, which is a 3% decrease in the State budget overall
 - Intergovernmental fines and fees

Expenditures:

- Increase in retirement costs and health benefit costs
- Materials budget is restored
- Salary and benefits - 77% of library budget
- Funding two positions for the library's literacy program, Project Second Chance (PSC). State funding has been reduced in literacy programs. PSC's positions were previously funded by the State and fundraising (which will continue).

County Librarian Anne Cain distributed a report and Board Order prepared by the County Administrator, that lists the recommended budget public hearings dates for fiscal year 2005-2006. (*attachment #6 to the minutes*). The handout demonstrates that the County anticipates a \$50.4 million budget shortfall. The library falls under the General Government Functional category on the chart with the 2.65%, or a \$1.0 million shortfall. The County's largest shortfall is in Health & Human Services and Public Safety, which accounts for a 54.9% or a \$20.9 million shortfall. Cain reiterated that the library's budget has been submitted and it is balanced. The library has restored the 25% cut in the materials' budget over the past two years. The library did not give a budget presentation to the Board of Supervisors last year in order to allow the Board to focus on departments that were facing difficult cuts and is not expected to give a budget presentation this year.

LIBRARY GIFTS AND COLLECTION DEVELOPMENT - Agenda Attachment 4

Julie Italiano, Collection Development/Technical Services Manager, reviewed the library's process for accepting gifts for the library's collection.

First, Italiano shared her library services background that includes twenty years with the Contra Costa County Library working in various libraries, and serving as Branch Librarian, opening new libraries including Clayton, and for the past two years managing Technical Services. She expressed her advantage that she has worked on both sides of library service and added that gifts are an important part of the collection.

The Technical Services' team developed a plan to manage gift donations, clear the backlog of new material, release current orders to vendors, and produce fund reports. Italiano explained that the plan was highly successful. She reviewed the details of the plan in the Commission agenda packet that included the number of gifts cataloged and processed for each library from December 2004 through February 2005.

In addition to catalog input, processing includes material evaluation, security stripping and labeling. Each library submits a quarterly statistical report that lists the number of titles added to the collection.

Library gifts, and the policy and procedure for accepting gifts, are outlined in the Commission agenda packet. Processing gift material is more time consuming compared to new orders that may come in multiple copies and be pre-labeled, such as the anticipated July 16, 2005 delivery of the new *Harry Potter* book. Gift material is folded into the daily receiving material process. Commissioners were informed about the selection criteria guidelines for gift material. Branch Librarians receive gifts and assess the material based on the library's collection. Gift material donated directly to Contra Costa County Library goes through a collection development distribution process.

Gift acceptance guidelines include:

- Gift material of an existing title in the library's catalog should meet one or more criteria:
 - New or like new
 - Can replace branch copy that is in poor condition
 - Newest edition of a nonfiction title
- Gift material that are not in the collection and need to be cataloged, in addition to one of the above criteria, must also:
 - Be written by a local author
 - Meet a need in the collection

The gift material priority schedule was reviewed and include items that:

- Compliment a grant
- Qualify as holds and new releases
- Local authors
- Local history
- International languages

Additional priorities in the Commission agenda packet were reviewed.

Italiano explained that online forms expedite and streamline the gift material processing. Library staff use an electronic form that is available on StaffNet (the library staff Intranet) if the gift item is not in the library catalog. Italiano demonstrated the online form that is used to request a new catalog item. This form is used for books only. Other formats of gift items, audiovisual, are shipped to Collection Development for review. All libraries have access to the forms and reports for new catalog requests. Library staff are able to check status of gift items by searching the new catalog requests, which can be sorted and searched.

If a collection of gift material is donated to the library, several avenues are considered:

- If the patron prefers supporting a particular community library
- Gifts submitted for the library's collection, and not a specific library, would go through a process to determine would determine where the items are needed most
- Special collections could involve working with the donor discussing various avenues for the collection

Commissioner Hoisington mentioned someone that is considering donating his collection of chess books to the library. Italiano explained that the library is in need of chess material, and that there is a library staff member who is very knowledgeable on the subject of chess. Middle school children in particularly have been inquiring about chess. This special collection of chess material would be a great addition to the library and Italiano suggested that the patron contact her.

Commissioner Myrick asked about adding videotapes to the collection and Italiano explained that the issue of security stripping, embedded security features, and sometimes these videos are weeded from the video stores for the same reasons that they are weeded from the library. The audiovisual problems are mainly with VHS tapes or DVDs. Any gift needs to fit the collection development policy and guidelines. Items from video stores may be acceptable, and would be evaluated on a case-by-case basis.

Responding to questions about gift criteria, Cain said that there is no upper limit to the value of a donation. The library's governing body is the Board of Supervisors and County policy is that the Board accept donations over \$5,000. Cain added that she does not recall the Board of Supervisors turning down a gift donated to the library. Commissioner Brown mentioned several books that the Orinda Friends would like in the Orinda Library's collection. Branch Librarians decide what is important to their specific collection, and must adhere

to the gift guidelines.

Commissioner Nolte asked how valuable donated books are handled. Some are added to the collection. Library Friends groups have occasionally encountered valuable material that they sold on EBay to benefit the library.

The library preserves local history, local authors, and California history, by storing items in the vault at the Central/Pleasant Hill Library. The library faces challenges in handling valuable collections. All library material is available for the public access. Certain material cannot be checked out of the building, such as certain reference material. Branch Librarians can decide to catalog certain material of value as reference. Branch Librarians can answer specific questions about historical California history items and the library's collection.

Commissioners were given a tour of the library's 'cage' that houses gift material and were shown the process that is used to place items into the collection at the conclusion of this meeting.

14. AGENDA SETTING FOR NEXT MEETING

Commissioner Enholm requested information on the opening dates of existing Contra Costa County Libraries and would like to know when the facilities were built. He would also like information identifying facility needs for each library.

15. ADJOURNMENT TO THE May 26, 2005 LIBRARY COMMISSION MEETING

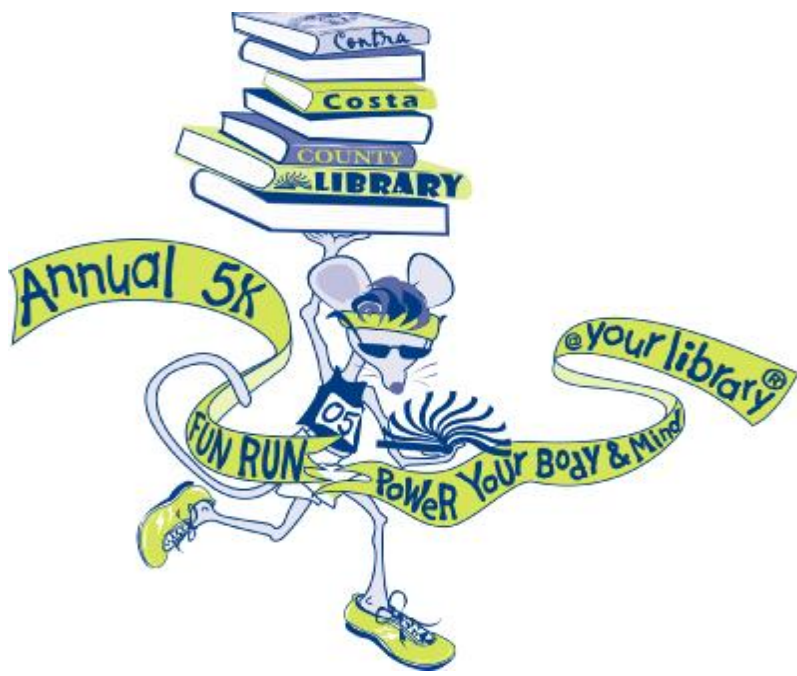

LATE FINES FOR MATERIALS IN VIDEO FORMAT SUMMARY

- Materials in video format (DVD/VHS) may be checked out for a maximum of 7 days and may be renewed once according to the County Library Circulation procedures.
- The Library increased late fines for video formats from one dollar to two dollars per day on May 1, 2003. The public was notified of this change 60 days prior to implementation. The maximum fine for videos per item is \$10.00.
- Total fines for DVD/VHS formats from January 1, 2003 to April 30, 2003 were \$21,366. Total fines for the same formats and time period in 2005 were \$38,937, an 81% increase. The new materials recovery service, UMS, generated an additional \$14,800 for the same period.
- Attachment 1 lists late fines charged on video formats in Fiscal Year 2003/04 for other Libraries in the greater Bay Area. Other libraries with a \$2.00 per day late fine for video formats include: Berkeley Public, Daly City, Marin County, San Francisco Public, and San Mateo City. San Leandro Public charges \$3.00 per day.
- Private companies that rent videos also charge fees for materials that are returned late. For example, Blockbuster will automatically convert the video rental to a purchase on the 8th day following the due date. The Blockbuster member has the option of returning the item within 30 days, and receiving a credit, but will then be charged a “restocking” fee. Restocking fees may vary by store.

Resolution on Section 215 of the USA PATRIOT Act

WHEREAS, Libraries are a critical force for promoting the free flow and unimpeded distribution of knowledge and information for individuals, institutions, and communities; and

WHEREAS, the Contra Costa County Library serves a diverse population, including citizens from other nations; and

WHEREAS, the Contra Costa County Library Commission holds that suppression of ideas undermines a democratic society; and

WHEREAS, Privacy is essential to the exercise of free speech, free thought, and free association; and in a library, the subject of users' interests should not be examined or scrutinized by others; and

WHEREAS, the Contra Costa County Library Commission affirms its strong opposition to any form of terrorism against humanity and also affirms that any effort to end terrorism must not be waged at the expense of civil rights and liberties; and

WHEREAS, the Contra Costa County Library Commission believes that certain provisions of section 215 of the USA PATRIOT Act expand the authority of the federal government to

- Obtain library records
- Secretly monitor electronic communication, and
- Prohibit libraries and librarians from informing users of such monitoring or information requests; and

WHEREAS, The USA PATRIOT Act increases the likelihood that the activities of library users may be under government surveillance without their knowledge or consent; and

WHEREAS, the Contra Costa County Board of Supervisors and organizations such as the American Library Association and the California Library Association, have adopted resolutions expressing concern about the Act, now therefore be it

RESOLVED, That the Contra Costa County Library Commission opposes the use of governmental power to suppress the free and open exchange of knowledge and information; and, be it further

RESOLVED, That the Contra Costa County Library Commission calls for the amendment of those provisions of section 215 of the USA PATRIOT Act that the Commission believes violate fundamental rights and liberties guaranteed by the United State Constitution, and be it further

RESOLVED, That the Contra Costa County Library Commission encourages the County Librarian to take steps to strengthen the Library's circulation and electronic systems and processes to further protect user privacy.
